If a couple has been living separately for any period during their partnership, they should provide evidence of the length of the periods of separation, the reasons for them, and how their relationship was maintained

- ☐ If you are coming to New Zealand for **24 months or longer** and you are 17 years of age or older, you must provide police certificates as evidence of your good character. See **how to obtain a Police Certificate** for information on what to do

- ☐ If you intend to be in New Zealand for **more than six months but less than one year**, you must provide evidence of a completed Chest X-ray Certificate (**INZ 1096**).

Please note that a chest x-ray certificate is NOT required if:

- › you have provided a Chest X-ray Certificate to INZ within the 36 months preceding this application, and
- › you have not spent the previous six consecutive months in China, Hong Kong or another country that is not a low-incidence country for tuberculosis (TB)

If you and your partner have been living together for 12 months or more you must provide evidence of completion of a Limited Medical Certificate (**INZ 1201**) and Chest X-ray Certificate (**INZ 1096**)

If you were eligible for an inclusion in your partner's earlier successful residence application, a General medical certificate (**INZ1007**) rather than a limited medical certificate must be provided.

Please note that a chest x-ray certificate is NOT required if:

胸部X光表在以下情况下无需递交:

- › a Chest X-ray Certificate has been provided to INZ within the 36 months preceding this application, and
- › you have not spent the previous six consecutive months in China, Hong Kong or another country that is not a low-incidence country for tuberculosis (TB). Since your previous Chest X-ray certificate was issued. Pregnant women and children under 11 years old are not required to have X-ray examination.

- › Note: All medical certificates must be completed by an INZ appointed panel doctor: www.immigration.govt.nz/paneldoctors
- › Certificate must be less than 3 months old when the application is submitted unless they were provided with an earlier visa application and were assessed as having an acceptable standard of health and were issued less than 36 months prior to the current application
- › Regardless of the length you and your partner have been living together, if you were eligible for an inclusion in your partner's earlier successful application for residence class visa, a general medical certificate rather than a limited certificate must be provided
- › The Panel Doctor will electronically submit x-ray and medical certificates directly to INZ
