Term	Definition
Arrival:	Each time an individual enters New Zealand.
Temporary Arrival:	Each time an individual enters New Zealand and is granted a Temporary permit. This does not include New Zealand nationals or those individuals who are refused entry into New Zealand.
Temporary Permit:	Any permit which does not entitle the holder for permanent residence in New Zealand
Visa Free:	Nationals from countries which have a visa free arrangement with New Zealand and who do not require a visa before being allowed into the country. Individuals from visa free countries can remain in New Zealand for a specified time on a visitor's permit without having to lodge an application for a permit unless they want to extend their stay or wish to work or study in New Zealand.
Visa Required:	Nationals from countries which do not have a visa free arrangement with New Zealand and who require a visa before being allowed into the country.

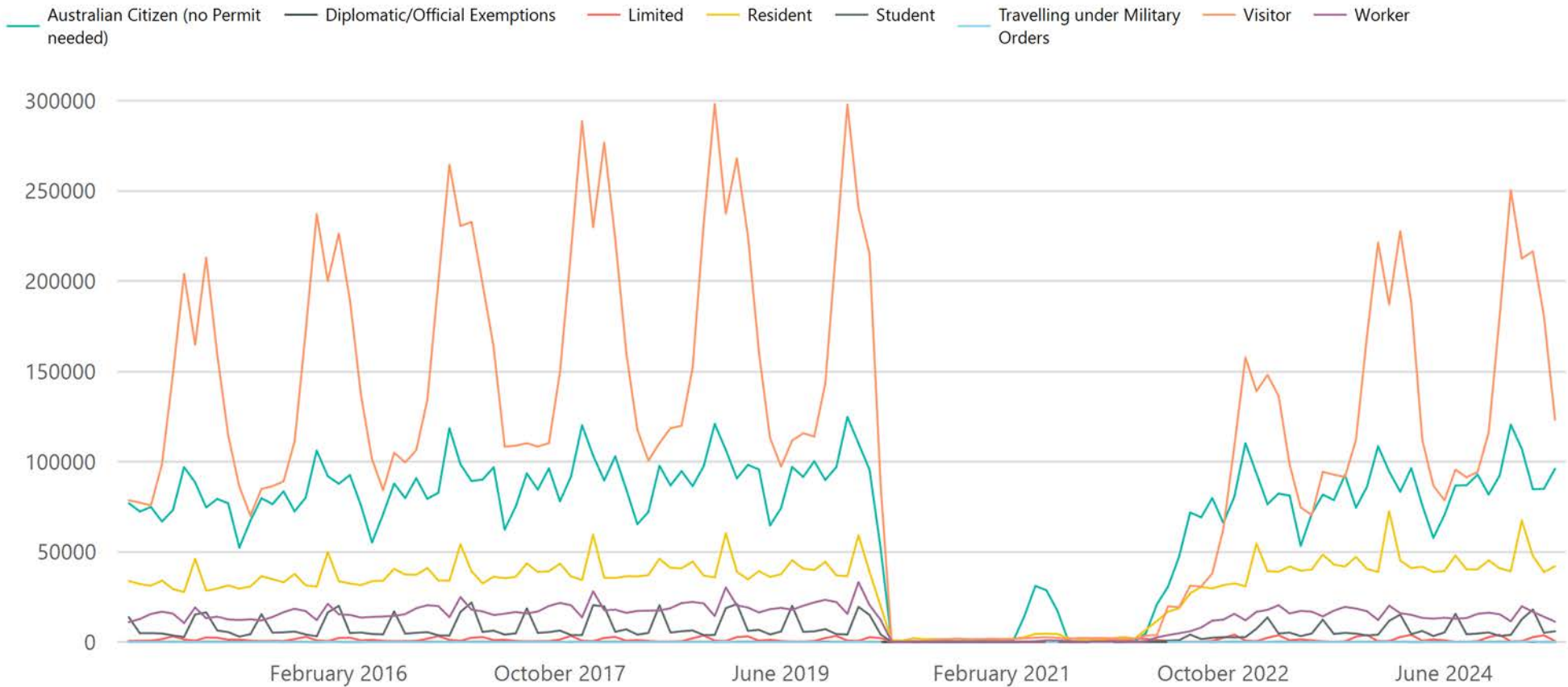
