Fees Guide



A guide to Immigration New Zealand's fees and levies

This guide provides information about the fees and levies Immigration New Zealand (INZ) charges, who has to pay and how to pay.

If we decline your application or request, we will not refund the fee and levies (if applicable).

## What do you pay?

## **Application Fees**

If you are in New Zealand when you make your application, you are required to pay the fee specified in Band A of the fees table on pages 3-4.

If you are outside New Zealand when you make your application, the fee you are required to pay depends on your country of citizenship. Citizens of Pacific countries specified below pay the fee in Band B. Citizens of all other countries pay the fee in Band C.

If paying in a currency other than NZD, the fee payable may vary slightly because of exchange rates.

#### New Zealand Electronic Travel Authority (NZeTA)

An NZeTA improves the way travellers are assessed before they arrive in New Zealand, and helps reduce the time needed for border clearance.

#### Immigration Levy

The purpose of the immigration levy is to fund:

- programmes to assist the successful settlement of migrants
- research into settlement issues and the impacts of immigration
- infrastructure required for, and the operation of, the immigration system
- activities aimed at attracting migrants to New Zealand
- the Immigration Advisers Authority to the extent that it is not otherwise funded.

An immigration levy is payable on certain visa applications, unless you are exempt. The levy is charged per application, unless the application is for a group visitor visa, in which case the levy is charged per person.

## People exempt from the immigration levy

You are exempt from paying the immigration levy if you:

- are a citizen of Samoa applying for a resident visa,
- are a claimant for refugee or protection status and applying for a visa,
- are applying for a resident visa as a refugee or protected person,
- are applying for a resident visa on the basis of your relationship with a refugee or protected person,
- are applying for a visa under the Refugee Family Support Category,
- are applying for a visa under the Special Category for Victims of Family Violence,
- are applying for a visa under the Special Category for Victims of People Trafficking, or
- are applying for a visa under the Skilled Migrant Category Job Search,
- are applying for a Migrant Exploitation Protection work visa,
- are applying for a visa as the partner or dependent child of a person who holds or is applying for a Migrant Exploitation Protection work visa.

International Visitor Conservation and Tourism Levy (IVL)

The purpose of the IVL is to fund:

- conservation
- infrastructure used for tourism
- · other initiatives related to tourism

An IVL is payable with NZeTA requests and for certain visa applications. The IVL is charged for each person included in the application. If you are required to pay the IVL and you apply online, the IVL payment will be included in the overall application amount.

## Dual citizenship

If you have dual citizenship you must pay the fee applicable to the passport used in your application.

## **Pacific countries**

The fees listed in Band B of the fees table on pages 3 to 4 apply to applications from citizens of Australia, American Samoa, Fiji, Kiribati, Marshall Islands, Federated States of Micronesia, Nauru, Palau, Papua New Guinea, Pitcairn Islands, Samoa, Solomon Islands, Tonga, Tuvalu, Vanuatu, and citizens of Cook Islands and Niue not travelling on a New Zealand passport.

Note: In the case of applications from citizens of French Polynesia, Guam, New Caledonia, and Norfolk Island, the fee band will differ for some application types. See www.immigration.govt.nz/fees for further information.

*Citizens of Pacific countries are exempt from paying the IVL, including Australian permanent residents.* 

## Fee-waiver countries

The New Zealand Government has bilateral fee-waiver agreements with certain countries. Citizens of those countries do not have to pay fees and the immigration levy (if applicable) for certain application types, as listed in the following table.

Fee waivers do not apply to the IVL or fee for replacing/transferring a visa label in a new passport.

# Partnership work visa fees

The work visa fees for 'Partnership work visa' on page 4 are for applications from partners of New Zealand citizens, residents, and temporary work and student visa holders.

# Do all family members have to pay?

All family members included in an application have to pay the IVL, unless exempt. You only have to pay one application fee and immigration levy for all of the people included in your application, except if applying for a group visitor visa or group transit visa. You can include your partner and/or dependent children in your application if you are applying for a:

- residence class visa
- variation of travel conditions on a resident visa
- visitor visa
- limited visa to visit New Zealand
- transit visa.

'Partner' means the spouse, civil union partner or de facto partner of the applicant where the couple have been living together for 12 months or more. This includes same-sex couples. See below for definitions of dependent children.

For all other application types, partners and children must make their own application for a visa and pay the required fee and immigration levy.

# Dependent children – residence class visa applications

You can include your/your partner's dependent children in your residence application if they are:

- aged 17 or under and single, or
- aged between 18 and 20 years, single, and have no children of their own, or
- aged 21 24, single with no children of their own and totally or substantially reliant on you or your partner for financial support.

Children aged 24 and under who are not dependent and children aged 25 or over must make their own application and pay the required fee and immigration levy.

## Dependent children – visitor/transit/ limited

You can include your/your partner's children in your application if they are 19 years of age or younger, unmarried and dependent. Children aged 19 and younger who are not dependent and children aged 20 or over must make their own application and pay the required fee and levies.

# **Rates for Fees and Levies**

**Explanatory note** – To determine the total amount an applicant must pay, add the fee in the applicable band to the amount in the immigration levy column and add the IVL per person in the application (if applicable). **Example 1:** When applying under the Residence – Family category while in New Zealand the total cost will be \$5360 per new fee and levy schedule (Band A fee of \$1940 + immigration levy of \$3420).

**Example 2:** An Indian citizen and their partner applying for a visitor visa while in India – the total cost will be \$541 per new fee and levy schedule and IVL (Band C fee of \$300 + immigration levy of \$41 + IVL of \$200 per new IVL of \$100 per person for two applicants).
