Where possible, original documents (especially military service/ exemption documents) must be submitted, along with certified translations where the originals are not written in English.

Please answer each question with as much detail as possible. If you do not provide sufficient information in your answers we may request clarification, which will delay the processing of your application. If you are not able to fit your answers into the space provided, complete your answers on an additional page and attach it to this form.

#### Immigration Advisers Licensing Act 2007
