## Who should use this form?

Use this form if you are applying for a visitor visa and, either:

- you are using the *Visitor Visa Application (INZ 1017)* and you wish to include more than four dependent children in your visitor visa application, or
- you are using the *Partnership-Based Temporary Visa Application (INZ 1198)* and you wish to include your dependent children in your visitor visa application.
- you are applying online and wish to include more than 10 dependent children in your visitor visa application.

When you have completed all the sections you need to, staple this form to the *Visitor Visa Application (INZ 1017)* or *Partnership-Based Temporary Visa Application (INZ 1198)*, or upload this form to your online application for a visitor visa.






