# Global Impact Work Visa Application

## Apply for your Global Impact work visa online – it's faster & easier

A Global Impact work visa should only be applied for once you have been offered a fellowship on the Global Impact programme. The fastest and easiest way to apply for a Global Impact work visa is online. Once you have your documents prepared, it should take less than 15 minutes to complete the online application form.

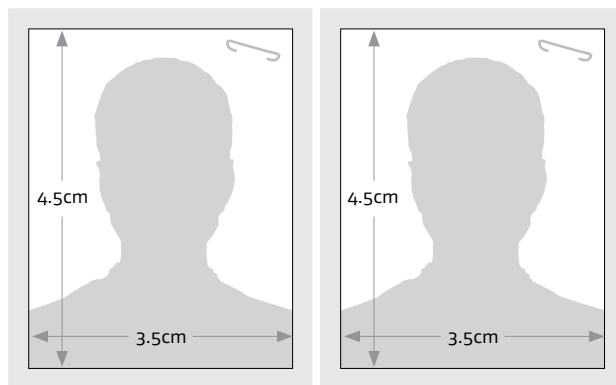

## Deciding whether you are eligible for a visa

Immigration New Zealand collects the information about you on this form to decide whether you are eligible for a work visa. We may also use the information to contact you for research purposes or to advise you on immigration matters.

Collecting the information is authorised by the Immigration Act 2009 and the Immigration Regulations made under that Act. You do not have to provide the information, but if you do not we are likely to decline your application.
