Sponsorship – Bank confirmation details

Supporting bank evidence as proof of sponsorship funds

Using this form

If you have completed the Sponsorship form for Temporary Entry online, and you have not provided bank statements/wage slips/a letter from your employer, then you are required to provide bank financial evidence to submit with your Sponsorship form which has been stamped by the Bank.

It is your responsibility to ensure that you have:

- sufficient funds for the maintenance of the sponsored person for the duration of their intended stay in New Zealand,
- sufficient funds to pay for the sponsored person's accommodation, or if you are providing accommodation directly, evidence that you own or have a rental agreement for the property where the sponsored person will stay while in New Zealand,
- sufficient funds to pay for the return travel of the sponsored person,
- (optional undertaking) funds of at least NZ\$9,000 available to pay for the cost of maternity health services in New Zealand if the sponsored person is pregnant and intending to give birth in New Zealand.

If you do not wish to share the reason for your request to verify your funds with the bank, then only print the second page.

Instructions to complete Section A

- Requestor's name (this should match the name on the online Sponsorship form)
- Visa Application Number (this can be found in your online Sponsorship form)
- Amount to be verified, include the amount you must have in order to meet your obligations. Make sure the bank confirms that you have at least this amount of funds available to you.

Note: The minimum amount of funds you will need to show to sponsor each person for a temporary entry visa is:

Visitor visa

- NZ\$1000 per person per month of stay if the accommodation has not been prepaid, or
- NZ\$400 per person per month of stay if the accommodation has been prepaid.

Student visa

- NZ\$17,000 per year (less any prepaid expenses) for students studying at primary, intermediate, or secondary school, or
- NZ\$1,417 per month (less any prepaid expenses) for students studying at primary, intermediate, or secondary school if study is shorter than a year.
- NZ\$20,000 per year (less any prepaid expenses) for tertiary students and non-compulsory education, or
- NZ\$1,667 per month (less any prepaid expenses) for tertiary students and non-compulsory education if study is shorter than a year.

All temporary visas

 NZD\$9,000 per person who is due to give birth while in New Zealand and who is not eligible for publicly-funded health services.

If you are sponsoring more than one person in one visa application, you will need to multiply the amounts above by the number of people you are sponsoring. If you are sponsoring multiple visa applications then you will need to complete one form per application.

Upload the completed Bank Confirmation form to include with your Sponsorship form to the Immigration Online system.
